## 2. Hazards Identification

**Emergency overview** Aerosol. CONTENTS UNDER PRESSURE.  
Prolonged exposure may cause chronic effects.

**Potential health effects**

**Routes of exposure** Ingestion.

**Eyes** Health injuries are not known or expected under normal use. Contact with liquid or mist will irritate the eyes.

**Skin** Frequent or prolonged contact may defat and dry the skin, leading to discomfort and dermatitis. Prolonged or repeated contact can result in defatting and drying of the skin which may result in skin irritation and dermatitis (rash).

**Inhalation** Intentional misuse by concentrating and inhaling the product can be harmful or fatal.

**Ingestion** Exposure by ingestion of an aerosol is unlikely. Components of the product may be absorbed into the body by ingestion.

**Target organs** Central nervous system.

**Chronic effects** May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion and blurred vision) and/or damage. Frequent or prolonged contact may defat and dry the skin, leading to discomfort and dermatitis.

**Signs and symptoms** Narcosis. Defatting of the skin. Skin irritation.

## 4. First Aid Measures

**First aid procedures**

**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

**Skin contact** Wash off with warm water and soap. Get medical attention if irritation develops or persists. Take off immediately all contaminated clothing.

**Inhalation** If symptoms develop move victim to fresh air. Get medical attention if symptoms persist.

**Ingestion** Do not induce vomiting without advice from poison control center. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Call a physician immediately.

<b>Flammable properties</b>	Vapor or gas may spread to distant ignition sources and flash back. Runoff to sewer may cause fire or explosion hazard.

<b>Suitable extinguishing media</b>	Water fog. Dry chemical. Carbon dioxide (CO <sub>2</sub> ).
<b>Protection of firefighters</b>	
<b>Protective equipment and precautions for firefighters</b>	In case of fire and/or explosion do not breathe fumes. Containers should be cooled with water to prevent vapor pressure build up.

## 6. Accidental Release Measures

<b>Methods for containment</b>	Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk.
<b>Methods for cleaning up</b>	Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal.
	Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

## 7. Handling and Storage

<b>Handling</b>	Pressurized container: Do not pierce or burn, even after use. Do not smoke while using or until sprayed surface is thoroughly dry. Do not use if spray button is missing or defective. Do not re-use empty containers. Avoid contact with skin. Avoid contact with eyes. Avoid prolonged exposure.
<b>Storage</b>	Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Keep away from heat and flame. Do not expose to heat or store at temperatures above 120°F/49°C as can may burst. Avoid exposure to long periods of sunlight. Keep out of the reach of children. Keep away from food, drink and animal feedingstuffs. Level 1 Aerosol (NFPA 30B)
