2. Hazards Identification

Emergency overview Aerosol. CONTENTS UNDER PRESSURE.

Harmful in contact with eyes. Prolonged exposure may cause chronic effects.

Potential health effects

Eyes Contact may irritate or burn eyes. Eye contact may result in corneal injury.

6. Accidental Release Measures

Methods for containment

Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk.

Methods for cleaning up

Should not be released into the environment. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

7. Handling and Storage

Handling

Pressurized container: Do not pierce or burn, even after use. Do not smoke while using or until sprayed surface is thoroughly dry. Do not use if spray button is missing or defective. Do not re-use empty containers. Do not get this material in contact with eyes. Avoid contact with skin. Avoid prolonged exposure.

Storage

Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Do not handle or store near an open flame, heat or other sources of ignition. Do not expose to heat or store at temperatures above 120°F/49°C as can may burst.
