2. Hazards Identification

Emergency overview CONTENTS UNDER PRESSURE. Aerosol. Irritating to eyes. Prolonged exposure may cause chronic effects.

Potential health effects

Eyes Causes eye irritation.

First aid procedures

6. Accidental Release Measures

Methods for containment

Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk. Prevent entry into waterways, sewers, basements or confined areas.

Methods for cleaning up

Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean contaminated surface thoroughly.

Pressurized container: Do not pierce or burn, even after use. Do not smoke while using or until sprayed surface is thoroughly dry. Do not use if spray button is missing or defective.
